Present: Steve Rathmann, Sal Fedele, Kevin Bartlett, Renee Wagner, Kurt Sundberg and Paul Hollman.

Sal Fedele stated that Public Comment would be accepted throughout the meeting as items were being discussed and before each vote.

Steve Rathmann made a motion to adopt the minutes from the February 11th and February 26th meetings. Kevin Bartlett seconded. No public comment was made. Motion carried unanimously.
