

April 13, 2020, 7:00 P.M., Greenfield Township Municipal Building, a regular meeting of the Greenfield Township Board of Supervisors. The meeting was held by Zoom video meetings, due to the Coronavirus. Notice of the meeting, instructions to participate, phone number and password were posted at the Township and listed on the answering machine. Present: Steve Rathmann, Sal Fedele, Kevin Bartlett, Renee Wagner, Kurt Sundberg, and Chris Bisbee.

Kevin Bartlett stated that Public Comment would be accepted throughout the meeting as items were being discussed and before each vote. No public was present in the meeting. Sal Fedele made a motion to adopt the minutes from the March 9th meeting. Steve Rathmann seconded. Motion carried unanimously.

The Treasurer's Report was reviewed.

Nothing to report on Wilson Road bridge over Darrow Brook.

Road inspection was postponed.

Chris Bisbee reported that six roads were still soft and recommended leaving them posted for review at the April 28th meeting.

The Employee work schedule was currently two on and two off, switching weekly. There was discussion of when to bring the full crew back. Orders for stay at home by President Trump, Governor Wolf and County Executive Dahlkemper were discussed.

Kevin Bartlett made a motion to continue the two on/two off schedule until the April 28th meeting. Sal Fedele seconded. Motion carried unanimously.

Kevin Bartlett reported that EMS calls were down, due to the Coronavirus.

There was discussion on the handling of Clean Up Days.

There was no need for the Township to pass an Ordinance regarding extension of the discount period for Real Estate taxes, as Erie County did not adopt the proposed Ordinance. No schools or seminars.

Mowing at the Park, Township property, Hornby Museum, Fire Station and roadsides was discussed. Sal Fedele offered to do the mowing, at the rate that was set by the Auditors (\$ 13.50/hour).

Steve Rathmann made a motion to have Sal Fedele do mowing on a part-time basis, at the Park, Township property, Hornby Museum, Fire Station and roadsides. Kevin Bartlett seconded. Motion carried. Sal Fedele abstained from voting.

Kevin Bartlett made a motion to pay the invoices as presented, Northwest 3072 through 3099 and PLGIT 10573 through 10592. Sal Fedele seconded. Motion carried unanimously.
